The Hanover Manor is located at 16 Eagle Rock Avenue in East Hanover, NJ 07936.

From New York City:

George Washington Bridge to Route 80 West. Get off at Exit 52. At end of ramp, make a right onto Two Bridges Road, which will lead into Passaic Avenue. At the end of Passaic Avenue, make a right onto Eagle Rock Avenue. Take Eagle Rock Avenue about one mile until you see Hanover Manor on the right.



Coming North on Garden State Parkway:

Take Parkway North to Exit 145 (Route 280). Take Route 280 West to Exit 4A. At first traffic light, turn right onto Eagle Rock Avenue. Go about one mile to Hanover Manor on the right.

Coming South on Garden State Parkway:

Take Parkway South to Route 80 West. Take Route 80 West to Exit 52. At the end of the ramp, make a right onto Two Bridges Road, which will lead into Passaic Avenue. At the end of Passaic Avenue make a right onto Eagle Rock Avenue. Take Eagle Rock Avenue about one mile until you see Hanover Manor on the right.

Coming From PA or Route 80 East:

Take Route 80 East to the Route 280 cutoff. Take Route 280 East to Exit 4A. At the first traffic light, make a right onto Eagle Rock Avenue. Take Eagle Rock Avenue about one mile to the Hanover Manor on the right.
